## Trustees' Annual Report

The trustees present their report with the financial statements of the charity for the year ended 29 February 2020. The trustees have adopted the provisions of the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015).

## OBJECTIVES AND ACTIVITIES

### Objectives and aims

The charity's object is the advancement of health and the relief of suffering of the sick for the benefit of the public by the making of grants or the provision of such other assistance to Bristol Eye Hospital (BEH) as BEH may request and as the trustees may in their absolute discretion see fit.

The charity does not contribute to core services for which the NHS is responsible.

### Review of activities and achievements

Friends of Bristol Eye Hospital have had another successful year in meeting our objective of supporting the work of BEH and helping its patients.

We continue to derive our income from membership subscriptions, donations, legacies and fundraising activities. Thanks to our many loyal and generous supporters, we continue to improve the care, treatment and comfort of patients, by providing for that which is beyond NHS resources.

We had 19 grants outstanding at the start of the year. During the year, the trustees received eight new requests for grants from BEH and were pleased to approve them all. Of these 27 grants, we have paid 18; two have been replaced by new grants, one was withdrawn by BEH and six remain in progress at the year end. Grants paid during the year included:

- Purchase and maintenance of HRT3 Rostock Cornea Module Confocal Microscope, used to diagnose microbial keratitis and other devastating, painful and sight-threatening conditions affecting the cornea. Examination with this microscope enables much better diagnosis and is much more comfortable for patients than the alternative unpleasant invasive procedure of "scrapes".
- Purchase and maintenance of Forus Neo Portable Wide-angled Retinal Camera for diagnosing early eye problems in babies and young children to help prevent them from losing their sight. The camera has a specially designed wide-angled lens that gives a unique close up view of blood vessels behind the eye. It's portable so it can be taken to babies who are too ill to be moved to BEH, for instance at St Michael's Hospital, the Paediatric Intensive Care Unit of the Bristol Royal Hospital for Children and even patients' homes. It provides high quality images more quickly and more efficiently than the two previous cameras that were funded by the Friends some years ago which have helped more than 1,000 babies. This grant was jointly funded by the Friends (paying one-third) and Above & Beyond (paying two-thirds).
- Keeler Classic Portable Slit Lamp (and carry case), Indirect Ophthalmoscope and Practitioner Ophthalmoscope plus an Icare Tonometer all for the on-call BEH A&E team to take to examine patients in other Bristol hospitals – a so-called 'grab bag'. While other Bristol A&E departments have access to slit lamps, ophthalmology technology has evolved to support quicker and more thorough review, diagnosis and treatment of eye conditions in less invasive ways which is particularly important when dealing with children or the elderly. Moreover, patients do not have to be transferred to BEH.
- Three iPads for Immunosuppression Support Nurses who counsel and screen patients (in all areas of BEH) prior to immunosuppression therapy care, including patients with ocular inflammation in the uveitis, corneal and adnexal services. By allowing nurses to access each patient's details (including, for example, ordering blood tests and checking results, pharmaceutical records, appointments and medical evidence regarding treatment regimens etc) from anywhere in BEH, the iPads greatly enhance the quality of care provided, improve efficiency and allow nurses to spend more time with each patient.
- Keeler Vantage Plus LED Indirect Ophthalmoscope
- Icare Pro (TA03) Tonometer
- Oslo Ophthalmic Patients Chair with Armrests
- Sponsorship of Clinical Audit Seminars for BEH Staff
- Counselling Training Course for Immunosuppression Support Nurse
- Electronic patient call system (including display screen, ticket dispenser, tickets and installation)

- TV for Patients in Pre-op department
- Lockers for staff in A&E (male changing rooms)
- Replacement Refrigerator for Staff Kitchen
- Christmas Decorations in Patient Reception areas

We also continued to maintain the two hospital gardens (for patients and staff), indoor plants and the aquarium in the children's ward.

We have introduced new processes to quicken the purchase of equipment funded by the Friends.

At our AGM in May 2019, Richard Markham, Kay McCluskey and Heather Walker were re-elected as trustees and James Reddish was first elected as a trustee, having been co-opted on 13 November 2018. Kevin Abbey was co-opted as a trustee on 20 November 2019.

Our new Donation and Membership Form issued in May 2018 invites new donors to tell us why they support us. This has proved most rewarding as many grateful patients have written kindly and appreciatively about their treatment and BEH staff – all most welcomed by staff (and by the trustees).

We held two fund-raising events during the year:

- A Race Night at Churchill Memorial Hall in May 2019 attended by 52 supporters was an entertaining triumph organised by Wendy & Nik Beatty. A total profit of £2,087 was generated by a very successful combination of sponsorship, advance 'selling' of horses plus auctions and betting on eight races. We gratefully acknowledge "The Kitchen Man" in Clifton who sponsored the event, all the Race Sponsors and everyone for their support.
- An evening with Mark Carwardine "*The Trials and Tribulations of a Zoologist*" at Ashton Court Mansion in September 2019 attracted exactly 100 guests raising a profit of £1,487. Many thanks to Mark for a fascinating and hugely enjoyable evening and to everyone who supported the event.

Over 60% of our total income in the year arose from legacies. Naturally such income varies significantly from year to year, but in the long run legacies account for the majority of our overall income.

Membership donations increased including significant growth in our regular donations.

We received large notable fund-raising donations or sponsorship from, amongst others, Alimera Sciences, Ashcombe Park Bowling Club, Bathampton Morrismen, Dyers' Company Charitable Trust, Moorwood Art, Novartis Pharmaceuticals UK Ltd, Royal Clarence Lodge, VISUfarma and Wendy House Nursery in Cannington. We were also very pleased to receive the proceeds from a raffle held by BEH staff at their Christmas social event.

As advised last year, our online donation platform MyDonate ceased to operate on 30 June 2019. Our new provider, the Wonderful Organisation, had commenced on 26 February 2019 and operated successfully through the year with 14 supporters using a credit or debit card without charge to pay us a total of £545 in donations, sponsorship or to buy event tickets. However, we were notified on 18 March 2020 that the service would cease on 31 March 2020 - as a consequence of the Covid-19 pandemic. We have appointed Donorbox as a replacement with effect from 10 April.

We have signed up to *Amazon Smile* which, like *Give as you Live*, enables anyone purchasing goods or services online to nominate us as a charity to receive a small percentage of the cost of their purchase.

After not issuing our newsletter *In Sight* in 2018 (we had no Publicity Officer), we published an enlarged 12 page edition of *In Sight* in March 2019 produced by our new Publicity Officer Kevin Abbey.

We have also considerably improved our publicity within BEH during the year, including:

- Four new display boards each containing copies of *In Sight* and Membership/Donation Forms to increase awareness and encourage new members and/or donors.
- A new large display near the BEH Boardroom (on the walkway off the stairs between the Ground Floor and Level 1). This is mainly aimed at staff but is also visible to patients using the stairs.
- A feather banner and two pull up display stands for use at our events and by our fund-raisers, such as the Ashcombe Park Bowling Club.
- Large promotional posters – one of which is displayed between the double doors at the main entrance into BEH – seen by thousands of patients and staff every day.

- New modern collecting goblets for distribution throughout BEH and elsewhere in and around Bristol.
- Moving our 'MoneySpinner' to a better location near the refurbished café and the patients' garden.
- Highlighting the location of the Friends' collecting box on the reception desk near the main entrance.
- Posters around BEH advertising our new facility to make donations by text on a mobile phone.
- At the invitation of the National Eye Research Council (NERC), based in BEH, we have written a leaflet explaining what the Friends do which NERC will distribute to all patients along with their own material seeking feedback for their research projects. The Friends do not fund research but seek to give immediate practical support to BEH and its patients.

We also subscribed to the Charity Choice website to promote ourselves amongst solicitors advising clients making wills - with a view to increasing our future income from legacies and to ensure that our name and Registered Charity Number are correctly recorded in wills or codicils. We are also working on a new leaflet to encourage and assist people who might wish to make bequests to us.

Above & Beyond informed us that, as part of their drive to raise funds for major refurbishment projects in Bristol hospitals, they were planning, with BEH's agreement, to boost their publicity and install contactless donation stations in BEH (and other Bristol NHS Trust hospitals) and enquired if we (and NERC) wished to do the same. After careful consideration, we decided not to do so as the potential returns did not justify the high installation and ongoing costs involved.

We have been working on a new website to be launched during 2020. This work includes a new logo which is being incorporated into our forms, documents and publicity material when they need to be reprinted for other reasons.

We made a few minor amendments to our Privacy Policy and published the new version on our website in May 2019.

Further details of our recent activities, including grants made, are contained in *In Sight* circulated to members and other supporters who request it. *In Sight* is also available at four locations in BEH, on our website or to anyone on request.

#### **Public benefit**

The trustees confirm they have complied with their duty to have due regard to the Charity Commission's guidance on public benefit in relation to the objectives and actions of the charity.

The trustees are satisfied and confident that the charity's activities directly further its charitable purposes and provide clear benefits to its beneficiaries, as demonstrated above. The charity's beneficiaries include any and all patients of the Bristol Eye Hospital and its staff.

## **FINANCIAL REVIEW**

### **Reserves Policy**

The reserves carried forward £121,909 (2019 - £146,330) are held in readily disposable investments and cash, for distribution as grants as required. At the balance sheet date the charity had funding commitments of £38,895.

In addition to funds set aside to pay for grants already approved but not yet paid, the trustees consider it appropriate to hold sufficient free reserves to cover at least one year's expected future operating costs (excluding any other grants to BEH).

The total funds at the end of the year exceed this amount; the trustees do not consider the reserves to be excessive and they will continue to approve and pay for grants to BEH out of these available reserves.

No funds are held as custodian trustee.

## **STRUCTURE, GOVERNANCE AND MANAGEMENT**

### **Governing document**

The charity was established on 13 April 1977. The charity is unincorporated; it is controlled by its governing document, a deed of trust, which was most recently updated on 18 May 2017 and approved by the Charity Commission on 12 July 2017.

### **Organisational structure**

The charity is managed by trustees. There must be at least six and not more than twelve trustees. One third of the trustees retire at the end of each Annual General Meeting and are eligible for re-election for a term of three years. Trustees elect a Chairman (who must be one of their number) and a Secretary and a Treasurer, all for fixed periods of office. A Chairman may not serve as such for more than six years.

Any member of the Friends who is eligible to be a trustee may stand for election at an Annual General Meeting. The trustees may, during the year, co-opt any eligible member to be a trustee to serve until the next Annual General Meeting, at which he or she may stand for election by the members.

The charity has three sub-committees (for Events, Finance and Governance), all of which have formal Terms of Reference as required by our governing document.

The charity has several further volunteers, including some hospital staff who advise the trustees. We thank all our volunteers for their work.

The charity has no employees.

### **Risk management**

The trustees have a duty to identify and review the risks to which the charity is exposed and to ensure appropriate controls are in place to provide reasonable assurance against fraud and error.

After a thorough review, the trustees have concluded that our activities should not be materially impacted by the Covid-19 crisis and that our charity remains a going concern. This review included an assessment of the possible impacts on our income, outgoings, asset values, delivery of our services and our governance – as recommended by Charity Commission guidance issued on 23 March 2020.

### **Statement of Trustees Responsibilities**

The trustees are responsible for preparing the Trustees' Report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards including Financial Reporting Standard 102: The Financial Reporting Standard applicable in the UK and Republic of Ireland (United Kingdom Generally Accepted Accounting Practice).

The law applicable to charities in England & Wales requires the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charity and of the income and expenditure of the charity for that period. In preparing these financial statements, the trustees are required to:

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles in the Charities SORP;
- make judgments and accounting estimates that are reasonable and prudent;
- state whether applicable accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements, and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in business.

**1. Accounting Policies**

**1.1 Basis of preparation**

The financial statements have been prepared in £ sterling on the historic cost basis and in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015) – (Charities SORP (FRS 102)).

The charity meets the definition of a public entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy.

**1.2 Income**

Income recognised in the period in which the Charity is entitled to receipt and the monetary value of income can be measured with sufficient reliability.

Dividends are recognised on the due date for payment and interest on a receivable basis grossed up for any recoverable taxation.

**1.3 Expenditure**

Liabilities are recognised as resources expended as soon as there is a legal or constructive obligation committing the Charity to the expenditure. All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category.

Costs of raising funds comprise the fees paid to the investment managers in connection with the management of the Charity's investments together with any other costs associated with the holding of investment assets.

Charitable activities include all direct and indirect costs incurred by the Charity in meeting its charitable objectives. Benefits payable are payments made to third parties in the furtherance of the charitable objectives of the Charity. Benefits payable are included in the Statement of Financial Activities when approved by the Trustees and the intended recipient has either received the funds or has been informed of the decision to pay the benefit. Where conditions are attached to the benefit, the benefits are accounted for when either the recipient has a reasonable expectation that they will receive the benefit and any condition attaching to it is outside of the control of the Trustees or the conditions attaching to the benefit have been fulfilled.

Governance costs comprise all costs incurred in running the charity itself as an organisation, and its compliance with regulation and good practice.

The Charity is not registered for VAT and irrecoverable VAT is aggregated with the expenditure on which it is incurred.

**1.4 Realised gains and losses**

All gains and losses are taken to the Statement of Financial Activities as they arise. Realised gains and losses on investments are calculated as the difference between sales proceeds and opening market value (or purchase date if later). Unrealised gains and losses are calculated as the difference between the market value at the year end and opening market value (or purchase date if later). Realised and unrealised gains are not separated in the Statement of Financial Activities.

**1.5 Current asset investments**

Current asset investments comprise instant access savings bonds, withdrawable at short notice.

**1.6 Debtors**

Debtors relating to accrued interest are recognised when unconditionally due and reasonable assurance can be gained they will be received.

**1.7 Cash at bank and in hand**

Cash at bank and in hand comprise cash on hand and call deposits, and other short-term highly liquid investments that are readily convertible to a known amount of cash and are subject to an insignificant risk of change in value.

**1.8 Creditors**

Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are recognised at their settlement amount.

Grants that meet the recognition criteria set out in note 1.3 but have not been paid as at the year end are recognised as a liability.

**1.9 Taxation**

As a registered charity, the charity is not liable to corporation tax to the extent that income and gains are applied to charitable activities.

**1.10 Funds**

General funds are unrestricted funds receivable or generated for the objects of the charity without specified purpose and are available as general funds.
