Leaving a gift in your Will

A Will is simply a legal document that enables you to ensure that those whom you would wish to benefit after your death – whether that's family, friends or a charity – actually do so. Not having a Will can make things difficult for those left behind. Some commonly asked questions:

Q. Do I need to see a solicitor to make a Will?

A. If your affairs are relatively simple, then you could write your Will yourself and include a legacy to benefit Friends of Bristol Eye Hospital. However, there are certain formalities that you must comply with to ensure the Will is valid. If your affairs are more complex, we encourage you to use a solicitor to prepare your Will.

Q. How do I leave money to Friends of Bristol Eye Hospital?

A. We have included suggested clauses on our website www.fbeh. org/support-us/wills-and-legacies/ which you or your solicitor could include in your Will.

Q. Do I need to be wealthy to make a Will and leave a legacy?

A. No! Even small amounts really make a difference to the work we do.

Q. I've already made a Will – can I easily change it to leave a legacy to Friends of Bristol Eye Hospital?

A. Yes, you use something called a codicil, which in effect adds or removes clauses to your existing Will. However, if the changes are significant, then it is recommended you seek professional advice as you may require a new Will.

Q. How do I ensure that my chosen charity will receive my legacy?

A. Please make sure your Will includes the correct Charity Name and their Registered Charity Number.
